



Terms and Conditions for Make a Zoozoo Face Competition (hereinafter referred to as "MZFC"/ "Competition"):

The MZFC is organized jointly by Vodafone Essar Limited, Vodafone Essar Mobile Services Limited, Vodafone Essar South Limited, Vodafone Essar Gujarat Limited, Vodafone Essar East Limited, Vodafone Essar Digilink Limited, Vodafone Essar Cellular Limited, Vodafone Essar Spacetel Limited (collectively as "Vodafone Essar") in their respective telecom service areas (as listed hereinbelow**) (hereinafter Vodafone Essar is referred to as "Organiser"). This Competition is open to all, subject to the terms and conditions of the MZFC.

Duration of the MZFC:

The MZFC starts from 28th Dec 2009 and shall be valid till 18th Jan, 2010 (both days inclusive).

In all there will be 3 rounds of the MZFC during the aforesaid period.

Eligibility to participate in the MZFC:

Who can participate?

Every person who is a resident of India may participate in this competition. Standard Multimedia Messaging Service (MMS) charges will be applicable.

How to Participate:

- (i) The eligible Subscribers ("Participants") may visit the www.vodafone.in website and may participate in the competition by viewing the Zoozoo face image displayed there, taking a snap of themselves imitating it and sending it as an MMS to the designated Vodafone email id/mobile number. Standard MMS charges will be applicable for this. In case of subscribers not being able to send it by the aforesaid method, they can also send the image/snap on a CD/DVD to "Make a Zoozoo Face competition", Vodafone Essar Ltd, Peninsula Corporate Park, Ganpatrao Kadam Marg, Lower Parel, Mumbai with their mobile number, name and a specification of which Zoozoo face they are imitating. All participation cost i.e courier, post, MMS and net usage charges will be borne by the participant, the organizer has no preferred mode of participation.
- (ii) Each winner shall get a branded Vodafone Zoozoo mug as a prize.
- (iii) There will be a total number of 200 winners of Vodafone Zoozoo mugs during the course of the MZFC.

Upto 200 winners of Vodafone Zoozoo mugs will be selected over the 3 weeks, basis photographs of imitations submitted and their names shall be announced on the www.vodafone.in website every week.

Gifts:

Please read these terms and conditions (including the above instructions which shall be considered to be integral part of the Terms and Conditions of this MZFC) carefully before registering / participating in the MZFC. By proceeding with registration for, and/or participating in the MZFC, you accept and agree to be legally bound by these terms and conditions:

1. The MZFC is open from 28th Dec 2009 till 18th Jan, 2010 (both days inclusive). All the entries sent by any available medium should reach the organizer on or before the abovementioned end date failing which the organizer will be at the liberty to reject/disqualify such entries.
2. All persons shall be entitled to participate in the MZFC. If, in any State and/or territory or part thereof, the running of this MZFC is prohibited, the Subscribers from such State and/or territory or part thereof shall not be eligible to participate in the MZFC. No further notice shall be given by the Organisers, in this regard.
3. There will be a maximum of 200 Winner/s of the MZFC and the selection shall be subject to these terms and conditions and further there shall be no consolation gift/s for subscriber participants even if their answer/s are similar to the Winner.
4. Selection of the Winner/s will be done by Vodafone Essar and / or its associates. No explanation or justification will be provided for selection of the Winner/s. Decision of Vodafone Essar shall be final.

The Organisers reserve the right to replace the Winner in case of non receipt of said information from the Winner within said 48 hours of being contacted by email. The gifts will only be delivered to an Indian Address no request to ship gifts outside India shall be entertained.
7. The Winner can be considered as disqualified for the Gift, in case he/she fails to clear all outstanding dues payable to Vodafone Essar.

The Subscriber/participant/winner hereby represents to Vodafone Essar that the MMS and its contents are not in violation of any law, morality and social/public conscience etc. and further the said MMS and its contents are not derogatory, defamatory, inflammatory and violation of privacy and/or intellectual property rights. The Subscribers/participant/winner hereby irrevocably authorize the Organisers, that the data gathered during and/or after the Competition in respect of the participants (including Subscriber name and photograph etc.) shall be the property of Vodafone Essar and Vodafone Essar shall be entitled to use the same in its communications including marketing promotions and advertisements along with/without Vodafone Essar's brand.
